14. COUNCIL BUSINESS

C. CONSIDERATION OF A RESOLUTION RECONFIRMING THE EXISTENCE OF A LOCAL EMERGENCY AND IMPOSING ADDITIONAL REGULATIONS DUE TO THE COVID-19 (CORONAVIRUS) PANDEMIC

City Attorney Peter Thorson presented the staff report. He indicated that one of the restrictions that the Council asked to be kept in place was for outdoor swap meets. The Council also asked for plans for the Rubidoux Swap Meet and their plans to re-open.

City Manager Rod Butler provided additional information on the Rubidoux Swap Meet and their plans to re-open. He responded to Council's questions.

Further discussion followed.

Council Member Chris Barajas discussed the new re-opening rules for swap meets, noting that the Rubidoux Swap Meet has already opened. Despite this development, he would prefer to build the City's relationship with them to ensure they are following the re-opening rules to keep the patrons and sellers safe.

Council Member Brian Berkson stated that he would pull his support for this item in light of the fact that the Rubidoux Swap Meet has opened for business before the new rules were approved.

Further discussion followed.

A motion was made by Mayor Anthony Kelly, seconded by Mayor Pro Tem Lorena Barajas, to adopt Resolution No. 2020-42, entitled:


